No vehicles, dogs or people are to stay overnight in the general parking area. NO generators are to be used between the hours of 11:00 P.M. to 6:00 A.M. anywhere on the show grounds unless approved by show chairs.

RV day parking is \$10.00 per day. This is NOT for overnight camping. Exhibitors planning to spend any night must complete a camping reservation.

Cars loading and unloading must leave 4-way flashers on and stay no longer than 15 minutes for loading or unloading. Parking is only allowed in designated areas. **No vehicles may drive in show area during show hours.**

TVKC & GVKC are not responsible for any fines or towing fees imposed for vehicles parked in areas other than the designated general parking areas or campgrounds.

From South: Interstate 390 North to Interstate 490 West, 490 West to Rt. 531 West to the end; turn right on Rt. 36 North, left on Rt. 31 West. Take Rt. 31 to Sweden Walker Road (Route 260). Right on Sweden Walker Road to Ridge Road. Left on Ridge Road to Route 19. Route 19 North to Hamlin.
